### What is the Creative in Schools Programme?

Creative in Schools is a joint Budget initiative between Ministry of Education, Ministry of Culture and Heritage (MCH) and Creative New Zealand (CNZ). The Ministry of Education runs the programme drawing on the expertise of the cross-agency working group which contains representatives from the three agencies.

The programme supports professional artists and creative practitioners to partner with schools and kura and share specialist artistic knowledge and creative practice with students. The creative learning experience intends to enhance students' wellbeing, improve their core competencies in communication, collaboration and creative thinking, and inspire their awareness of careers in the arts and creative sectors. ## What is this evaluation for?

The evaluation's purpose is to provide insight to support and improve implementation of the Creative in Schools programme and identify where to fine-tune the programme in the future. Overall, the evaluation provides information in three key areas of inquiry.

To what extent and in what ways does:

- Creative in Schools work as intended and deliver on the expected objectives?
- Creative in Schools produce valuable outcomes and impacts?
- · Creative in Schools provide value?

The evaluation will be based on feedback from key stakeholders, including students, teachers and schools, creatives, parents and whānau. It includes feedback on using the Arts Online website's Available Creatives webpage to find a Creative Practitioner for the project.

The results will inform the cross-agency working group of the strengths and weaknesses of Creative in Schools and identify opportunities to develop the programme further. The evaluation will also document programme outcomes so far, and the value to Māori, Pacific and the broader community.
